Facilities

Housing and Residence Life (HRL) has both traditional suite-style residence halls and apartments. Apartment housing began in fall 1984 with McDonald East and the first residence hall opened in 2001. In fall 2010, 2,804 USI students lived on campus in USI's four residence halls and 43 apartment buildings.



Demand for Housing

Student housing continues to be in high demand. In fall 2010, 140 students seeking to live on campus were placed in Eagle Village, a nearby, non-USI apartment complex. The most popular choice is residence halls. Despite 236 units with a total of 814 bed spaces in the residence halls, requests continue to exceed capacity. Below is the percentage of residents who received their first choice of housing:

In fall 2010, one in four of the 1,051 freshmen who wanted to live in the residence halls could not be accommodated, resulting in 51% of freshmen residents living in USI apartments.

LLC Impact on Retention

New freshmen one-year retention rates are significantly higher among those in Living Learning Communities, despite a slight dip in fall 2009. Freshmen who live in regular residence halls or USI apartments are retained at the same rate as commuter students.
