

MINUTES

UNIVERSITY OF SOUTHERN INDIANA BOARD OF TRUSTEES

March 1, 1990

The University of Southern Indiana Board of Trustees met in the University Center on Thursday, March 1, 1990. Present were Trustees Bruce Baker, William Brooks, Jr., Percy Clark, Jr., Joseph O'Daniel, John Pruis, Carole Rust, Brad Schepers, and George Weathersby. Also attending were President David Rice; Vice Presidents Donald Bennett, Robert Reid, Sherrianne Standley, and Byron Wright; and Faculty Senate Chairperson Larry Goss.

There being a quorum present, Mr. O'Daniel called the meeting to order at 1:30 p.m.

SECTION I - GENERAL AND ACADEMIC MATTERS

A. APPROVAL OF MINUTES OF JANUARY 11, 1990, MEETING

On a motion by Dr. Weathersby, seconded by Mr. Brooks, the minutes of the January 11, 1990, meeting were approved.

B. ESTABLISHMENT OF NEXT MEETING DATE, TIME, LOCATION

The next regular meeting of the Board of Trustees was set for Friday, May 11, 1990, at the University of Southern Indiana.

C. PRESIDENT'S REPORT

Dr. Rice reported to the Board that the University will award approximately 700 degrees at Commencement on May 12. He said that the honorary degree candidates, who played a significant role in the early development of the University, were chosen in honor of our 25th anniversary.

He also said that the Jacob Maentel exhibit will be at the Indiana State Museum February 17 - April 8 and in New York July 5 - September 2.

Dr. Rice announced that six individuals associated with the University have art work on display at the new Evansville Courier building.

Dr. Rice reported that Dr. Aldo Cardarelli received a grant from the Lilly Endowment to fund a reading program for middle school teachers.

D. REPORT OF JOINT MEETING OF LONG-RANGE PLANNING COMMITTEE AND FINANCE COMMITTEE

Dr. Clark presented the report of the joint meeting of the Finance Committee and Long-Range Planning Committee. He said discussion centered on the 1990-91 operating budget, including student fee increases and salary increases. He added that the committee also discussed a summary of bids for the Science Center renovation and Section 125 of the Internal Revenue Code.

E. APPROVAL OF CANDIDATES FOR DEGREES

The candidates for master, baccalaureate, and associate degrees, to be conferred May 12, 1990, are listed in Exhibit I-A.

On a motion by Dr. Weathersby, seconded by Mr. Schepers, award of the respective degrees was approved subject to the completion of all requirements.

F. APPROVAL OF CANDIDATES FOR HONORARY DEGREES

On a motion by Dr. Pruis, seconded by Dr. Weathersby, the conferral of the following honorary degrees at the May 12, 1990, Commencement was approved.

Doctor of Letters to Judith A. Clabes, editor of the *Kentucky Post*, who will bring the Commencement Address.

Doctor of Science to John W. Fehrenbacher, cardiovascular surgeon in Indianapolis and a 1971 University of Southern Indiana graduate.

Doctor of Laws to Daniel A. Miller, University of Southern Indiana professor emeritus of history.

SECTION II - FINANCIAL MATTERS

A. APPROVAL OF BUDGET FOR YOUNG ABE LINCOLN MUSICAL OUTDOOR DRAMA

The proposed budget for the Young Abe Lincoln Musical Outdoor Drama is presented below. The Indiana Department of Natural Resources (DNR) will provide financial support of up to \$200,000 to cover any excess of expenses over revenue for the 1990 production.

On a motion by Dr. Pruis, seconded by Dr. Weathersby, the following budget for the 1990 production of the Young Abe Lincoln Musical Outdoor Drama was approved.

The resolution to establish a fiscal year for the Young Abe Lincoln Musical Outdoor Drama is included in section II, item F.

B. APPROVAL OF RESOLUTION FOR PRE-TAX PREMIUM CONVERSION PLAN FOR EMPLOYEES PARTICIPATING IN HEALTH INSURANCE PROGRAMS

Under section 125 of the Internal Revenue Code, the University can establish a premium conversion plan whereby active employees are able to pay their share of premiums for health care prior to the application of federal, state and local income taxes and FICA (Social Security and Medicare) taxes.

Participation by employees is optional. Participants save taxes applicable to the amount of premiums they would otherwise have to pay out of after-tax income. The University saves its matching share of FICA taxes. Because these premium contributions are subject to FICA tax, a participant's ultimate Social Security benefits could be decreased in those instances where the participant's earnings subject to FICA tax are less than the annual earnings base subject to tax.

Deductions from gross pay will not affect the University retirement benefits nor the amount of life insurance and accidental death and dismemberment insurance to which a participant is entitled.

In order to allow sufficient time to explain the program and to enroll participants, it is proposed that the effective date of the plan be April 1, 1990.

On a motion by Dr. Weathersby, seconded by Mrs. Rust, the following resolution to establish a Premium Conversion Plan effective April 1, 1990 was approved.

- WHEREAS, the University may, under Section 125 of the Internal Revenue Code, establish a premium conversion plan for employees, and
- WHEREAS, Under this plan employees would not be required to pay taxes on their share of the health care premiums, and
- WHEREAS, The tax savings would result in an increase in take-home pay,

NOW THEREFORE BE IT RESOLVED that the Board of Trustees approve the Premium Conversion Plan in the preceding description.

C. REJECTION OF SCIENCE LABORATORY BIDS AND APPROVAL FOR REBIDDING PROJECT

Bids were received on February 20, 1990 for remodeling Science Center classrooms into science laboratories. A summary of the bids received is included in Exhibit II-A.

The lowest bid or combination of bids is 42 percent above architect and engineer cost estimates and exceeds available funding. On a motion by Dr. Weathersby, seconded by Mr. Brooks, all bids were rejected, and the following plan for rebidding the Science Laboratories project was approved as amended.

It is necessary to rework the plans and specifications for the science laboratories due to the excessive bids received February 20, 1990. Therefore, it is recommended that the architect be instructed to (1) revise plans and specifications to be within available resources, (2) submit revised plans to prospective bidders, and (3) receive new bids. It is further recommended that the Chairman of the Board of Trustees appoint a committee to review and approve, if acceptable, the new bids and to report its action at the next meeting of the Board of Trustees.

D. APPROVAL OF AUTHORIZATION FOR FINANCIAL AID AWARDS

On a motion by Mr. Baker, seconded by Dr. Pruis, the following authorization for financial aid awards was approved.

Pursuant to Indiana Code 20-12-1-2, which provides for awarding financial aid to students from existing resources, the University of Southern Indiana Board of Trustees delegates to the President of the University of Southern Indiana the responsibility to approve financial aid recommendations for students within the 1990-91 budgetary capabilities.

E. APPROVAL OF BUDGET APPROPRIATIONS, ADJUSTMENTS, AND TRANSFERS

On a motion by Dr. Weathersby, seconded by Mrs. Rust, the following Budget Appropriations, Adjustments, and Transfers <u>were approved.</u>

F. APPROVAL OF RESOLUTION TO ESTABLISH A FISCAL YEAR FOR THE YOUNG ABE LINCOLN MUSICAL OUTDOOR DRAMA

On a motion by Mrs. Rust, seconded by Dr. Weathersby, the following resolution to establish a fiscal year for the Young Abe Lincoln Musical Outdoor Drama was approved as amended.

- WHEREAS, the production for the Young Abe Lincoln Musical Outdoor Drama is September 1 through August 31, and
- WHEREAS, the University needs budgetary authority to expend monies for the production throughout the production year,
- THEREFORE BE IT RESOLVED that the Board authorizes the expenditure of monies by the University for the Young Abe Lincoln production from September 1 through August 31 during each year, in accordance with the budget approved by the Board.

SECTION III - PERSONNEL MATTERS

A. APPROVAL OF AUTHORIZATION FOR EMPLOYMENT OF FACULTY AND STAFF

Pursuant to Indiana Code 20-12-1-4 the University of Southern Indiana Board of Trustees on March 2, 1989, authorized the President of the University of Southern Indiana to employ faculty and staff, and to establish salaries and wages within budgetary capabilities.

On a motion by Dr. Weathersby, seconded by Mrs. Rust, it was approved that the Board of Trustees authorizes the President of the University of Southern Indiana to employ qualified faculty and staff, to grant leaves of absence, and to establish salaries, wages, and benefits for employees within the capabilities of the budget. Further, the Board, which establishes the employment contract for the President of the University, including salary and benefits, authorizes the chairman of the Board to convey to the President his employment contract, including salary and benefits.

B. APPROVAL OF PERSONNEL ACTIONS

On a motion by Dr. Weathersby, seconded by Mrs. Rust, the following personnel actions were approved as amended.
