MINUTES

UNIVERSITY OF SOUTHERN INDIANA BOARD OF TRUSTEES

April 28, 2017

The Board of Trustees of the University of Southern Indiana met on Friday, April 28, 2017, in University Center East on the University campus. Present were Chair Jeffrey L. Knight and Trustees W. Harold Calloway; John M. Dunn; Ellis S. Redd; Ronald D. Romain '73; Evan K. Stieler '17; and Ted C. Ziemer, Jr. Trustees Amy MacDonell and Kenneth L. Sendelweck '76 were absent. Also in attendance were President Linda L. M. Bennett; Provost Ronald S. Rochon; Vice President for Finance and Administration Steven J. Bridges '89 M'95; Vice President for Government and University Relations Cynthia S. Brinker; Vice President for Development David A. Bower; Vice President for Enrollment Management Andrew W. Wright; Faculty Senate Chair Nicholas LaRowe; and Student Government Association President Christina Lutes '18.

Chair Knight called the meeting to order at 3 p.m.

SECTION I - GENERAL AND ACADEMIC MATTERS

A. APPROVAL OF MINUTES OF MARCH 2, 2017, MEETING

On a motion by Mr. Ziemer, seconded by Mr. Calloway, the minutes of the March 2, 2017, meeting of the Board of Trustees <u>were approved</u>.

B. ESTABLISHMENT OF NEXT MEETING DATE, TIME, LOCATION

Mr. Knight called on Vice President Brinker, who reported the next meeting of the Board of Trustees is scheduled for Thursday, July 13, 2017, in the Griffin Center on campus.

Under Indiana law (IC 21-14-2-7 and IC 21-14-2-8), each state university is required to set tuition and fees for a two-year period following the adoption of the state's biennial budget, and to hold a public hearing before the adoption of any proposed rate increases. Vice President Brinker reported the Trustees will be notified when a date for the public hearing is scheduled.

C. PRESIDENT'S REPORT

Dr. Bennett began her report by calling on Vice President Brinker to review the Commencement activities planned for the weekend. Ms. Brinker noted that 80 percent, or 1,199 of the 1,496 students eligible to graduate, will participate in Spring Commencement. She outlined the schedule of the five ceremonies:

Following each ceremony, the USI Alumni Association will host a reception in University Center East.

Dr. Bennett reported since 1990, past and current members of the Board of Trustees have generously contributed to build a permanent endowment in the USI Foundation for the Trustees Distinguished Merit Award. The awardee is selected by the Faculty Senate Student Affairs Committee. It recognizes outstanding achievement in the student's major and in the core curriculum and includes a \$2,000 stipend. President Bennett announced the 2017 recipient of the award is Carlos Caballero-Ramirez, who will receive a Bachelor's Degree in Health Services during the College of Nursing and Health Professions ceremony. She thanked the Trustees for their generous support of the Trustees Distinguished Merit Award.

President Bennett highlighted another important award, the President's Medal, also celebrated at the Commencement Luncheon. Evan K. Stieler '17 will receive the President's Medal, the highest award given to a USI graduate, when he graduates *summa cum laude* with a Bachelor of Science in Biology during the Pott College of Science, Engineering, and Education Ceremony.

President Bennett called on Provost Rochon, who introduced Activities Programming Board (APB) President Angela DaCosta '18 and Student Government Association (SGA) President Christina Lutes '18 for a report of their organizations' activities during the 2016-2017 academic year. Ms. DaCosta reported on several of the over 70 programs planned throughout the year to provide students with entertainment and educational activities. She noted that through these events APB had nearly 10,000 student interactions allowing the organization to reach new and diverse groups of students across campus. Ms. DaCosta advised that in 2016-2017 APB had 48 general members, a record high, who volunteered a combined 700 hours to the organization.

Ms. Lutes began the annual report of SGA by noting SGA's varying roles on campus. The organization serves as a liaison between students and the faculty/administration; builds strong leaders; serves as a forum for student groups to voice their concerns; assists students with funding for travel; and works to improve school spirit. Ms. Lutes summarized the highlights of SGA's activities for the year including another successful Alcohol Awareness Week in October, a Rare Disease Student Discussion Panel, and a successful effort to include majors on diplomas, beginning with spring 2017 Commencement. SGA members participated in the annual Student Government Coalition Conference; the annual USI Day at the State House; and Walk a Mile in Her Shoes, an annual event to raise awareness and stop rape, sexual assault, and gender-based violence. Ms. Lutes concluded her report by introducing Katelyn Bueltel '19, a junior business administration major elected SGA President for 2017-2018. President Bennett expressed her appreciation to Ms. DaCosta and Ms. Lutes for their leadership in 2016-2017.

President Bennett invited Vice President Andrew Wright to give the Enrollment Management report. Mr. Wright provided the Board with an admission and enrollment update for fall 2017 and advised that Undergraduate Admissions and Graduate Admissions continue to make outreach efforts aimed at applicants and newly admitted students, while University Division advising staff and the academic colleges reach out to continuing students not yet registered for classes.

The President called on Vice President for Development David A. Bower for a report. Mr. Bower advised that current gift commitments for the 2016-2017 fiscal year total \$6.4 million. Mr. Bower updated the Trustees on other Foundation activities including progress on plans for the Foundation's 50th Anniversary, which will be celebrated in 2018. In closing, he discussed the importance of the *Here and Now Fund*, the Foundation's unrestricted gift fund designed to assist students in urgent situations.

President Bennett called on Dr. Nicholas LaRowe for a report from Faculty Senate and thanked him for his service and leadership as chair of Faculty Senate in 2016-2017. Dr. LaRowe reported that Faculty Senate has formed and populated an ad hoc committee to conduct a review and overhaul of student course evaluations beginning in fall 2017. Dr. Richard Bennett, associate professor of Biology, will chair the Committee. Dr. LaRowe advised that the Faculty Awards for Service, Teaching, and Research Committee met and selected winners, who will be announced at a later date. In closing, Dr. LaRowe noted that the Faculty Senate elections were nearing completion and thanked the senators whose terms are ending. Dr. LaRowe announced that Peter Whiting, associate librarian for the David L. Rice Library will serve as Faculty Senate Chair for 2017-2018.

President Bennett called on Student Government Association (SGA) President Christina Lutes '18 for her final report. Ms. Lutes noted that the annual report from AGB/SGA just presented would take the place of the regular report from SGA. She thanked President Bennett and the Board members for their support during her tenure as President.

In closing, President Bennett thanked Ms. Lutes for representing USI students in Board of Trustees meetings and events for the spring 2017 semester and welcomed SGA president elect, Katelyn Bueltel '19, who will join the Board of Trustees at the table in July 2017.

D. APPOINTMENT OF THE NOMINATING COMMITTEE

Mr. Knight appointed Ms. MacDonell, Mr. Dunn, and Mr. Romain to the Nominating Committee, with Mr. Romain as chair. The Nominating Committee will prepare a slate of officers to be presented to the Board of Trustees at its annual meeting on July 13, 2017.

E. REPORT ON THE INDIANA GENERAL ASSEMBLY

Mr. Knight called on Vice President Brinker for a report on the Indiana General Assembly and thanked her for her leadership in the budget session. Ms. Brinker referred the Trustees to Exhibit I-A and reviewed the 2017-2019 Performance Funding Formulas. USI's operating base was reduced by 4.1 percent (\$1,823,770) for fiscal year 2018 and 4.2 percent (\$1,867,238) for fiscal year 2019 to fund the performance funding formulas. The four metrics included in the formula for USI were: overall degree completion; on-time degree completion; at-risk degree completion; and student persistence incentive. USI earned approximately \$1.8 million for fiscal year 2018 and \$2.3 million in fiscal year 2019 from the formulas. The actual increase in the University's operating appropriation is \$1,394 or 0.0 percent in 2017-2018 and \$420,449 or 0.9 percent in 2018-2019.

Ms. Brinker reviewed the line item appropriation for Historic New Harmony of \$ \$486,878, which remains unchanged from the 2015-2017 appropriation. She reviewed the line item appropriation to fund dual credit priority courses taught in high schools statewide which is \$302,550 funded at \$50 per credit hour. Ms. Brinker discussed two new line item appropriations for the upcoming biennium: Campus Security Enhancement appropriation of \$750,000 and USI Stem Initiatives appropriation of \$500,000 designed to enhance engineering, advanced manufacturing and innovation in southwest Indiana through the expansion of engineering degree programs and STEM outreach initiatives.

Related to capital projects, \$41 million in bonding authorization in fiscal year 2019 was approved by the General Assembly for the Physical Activities Center Phase II Expansion and Renovation Project. In addition, the General Assembly approved an appropriation of \$1.8 million for general repair and rehabilitation.

Ms. Brinker reported on other legislation pertaining to higher education, including:

- Immunizations for Higher Education Students;
- · Executive Sessions and Open Records;
- Government Information;
- Fee Remission Program to Children and Spouses of Disabled Police and Firefighters;
- Career and Technical Education; and
- Sanctuary Policies and Postsecondary Educational Institutions.

F. APPROVAL OF RESOLUTION OF APPRECIATION TO TRUSTEE EVAN K. STIELER '17

Mr. Knight called on Mr. Romain who presented the following resolution.

WHEREAS, Evan K. Stieler was appointed to the University of Southern Indiana Board of Trustees by Indiana Governor Mike Pence in July 2015, becoming the fifteenth student to be so appointed in the history of the University; and

WHEREAS, Mr. Stieler has served with distinction as a member of the Board for two years; and

- WHEREAS, Mr. Stieler has served the Board of Trustees as a member of the Finance/Audit Committee, Academic Affairs and Enrollment Management Committee, and has represented the Board as a member of the USI Foundation Board of Directors; and
- **WHEREAS**, through active leadership and communication with the Student Government Association and other student groups, he has caused positive progress in the area of student governance; and
- **WHEREAS**, during his tenure as a Trustee, the University experienced the development of opportunities in academics, student life, and the expansion of facilities, including the Griffin Center; and
- WHEREAS, in March 2016, Mr. Stieler joined his colleagues on the Board of Trustees in approving the University's second five-year strategic plan to guide the University from 2016 to 2020; and
- **WHEREAS,** Mr. Stieler has excelled in all areas of student life, including academics, and leadership; and
- WHEREAS, his term on the Board of Trustees will expire on June 30, 2017.
- **NOW, THEREFORE, BE IT RESOLVED**, that the members of the USI Board of Trustees express to Evan K. Stieler their sincere appreciation for his involvement and his vision; and
- **FURTHER RESOLVED**, that the Board wishes Mr. Stieler well as he graduates from USI and pursues a Master of Business Administration and a degree in medicine; and
- **FURTHER RESOLVED**, that this resolution be adopted by the Board of Trustees and spread upon its minutes for all time as a perpetual recognition of the deep gratitude owed by the University and its trustees, officers, students, and faculty, to Evan K. Stieler for his devoted service to the University of Southern Indiana.

On a motion by Mr. Romain, seconded by Mr. Redd, the Resolution of Appreciation to Trustee Evan K. Stieler '17 was approved.

G. APPROVAL OF POSTHUMOUS DEGREE

Mr. Knight called on Provost Rochon, who recommended approval of a posthumous degree for Allison Marie Schafer. He reported this action is recommended by the dean of the College of Liberal Arts, in consultation with the undergraduate faculty of the Sociology Department.

On a motion by Mr. Ziemer, seconded by Mr. Redd, the following posthumous degree was approved.

SECTION II - FINANCIAL MATTERS

A. REPORT OF FINANCE/AUDIT COMMITTEE MEETING

The Finance/Audit Committee met in special session on April 10, 2017, on campus. Mr. Knight called on Mr. Dunn, who chaired the Finance/Audit Committee meeting in Committee Chair Calloway's absence. Mr. Dunn advised that the Committee reviewed construction bids and awarded contracts for the Physical Activities Center Renovation Project, and approved the issuance of Bond Series L and refunding of Bond Series J Refinance Plan.

B. REPORT ON CURRENT CONSTRUCTION PROJECTS

Mr. Knight called on Vice President Bridges, who introduced Director of Facility Operations and Planning Jim Wolfe for a report on current construction projects. Mr. Wolfe shared plans of the design of the PAC Renovation Project and showed the Board architect renderings. He provided an update on the Health Professions Center Third Floor Renovation Project and construction of the Multi-Institutional Academic Health and Science Research Center. He referred the Trustees to Exhibit II-A for a list of projects and a summary of the cost and funding sources for each project.
