# 1. INTERVIEW FIRMS INTERESTED IN PROVIDING ARCHITECTURAL AND ENGINEERING SERVICES FOR THE COLLEGE OF BUSINESS/CLASSROOM BUILDING PROJECT

Will Sr. Also in attendance were Vice President for Business Affairs and Treasurer Mark Rozewski; Provost and Vice President for Academic Affairs Linda L. M. On a motion by Mr. Huber, seconded by Mr. Will, the firms/teams of Goody Clancy and Odle McGuire & Shook; SmithGroup and Veazey Parrott Durkin & Shoulders; and Perkins + Will and Woollen, Molzan, and Partners were eliminated from further consideration.

Mr. Will moved that the committee select VOA Associates to design the project. Mr. Day seconded the motion. Following discussion, Mr. Will and Mr. Day withdrew the motion.

Following a vote of the committee members, on a motion by Mr. Day, seconded by Mr. Will, the team of Hellmuth, Obata + Kassabaum and Hafer Associates was selected to design the project.

There being no further business, the meeting adjourned at 5:35 p.m.
