#### MINUTES

#### UNIVERSITY OF SOUTHERN INDIANA BOARD OF TRUSTEES

#### May 2, 2014

The Board of Trustees of the University of Southern Indiana met on Friday, May 2, 2014, in University Center East on the University campus. Present were Chair Ted C. Ziemer, Jr. and Trustees Ira G. Boots; Brenden Davidson '15; John M. Dunn; Jeffrey L. Knight; Amy MacDonell; Ronald D. Romain '73; and Kenneth L. Sendelweck '76. Also in attendance were President Linda L. M. Bennett; Provost Ronald S. Rochon; Vice President for Finance and Administration Mark Rozewski; Vice President for Government and University Relations Cynthia S. Brinker; Faculty Senate Chair Mary Hallock Morris; and Student Government Association President R. Zachary Mathis '15.

Chair Ziemer called the meeting to order at 1:46 p.m.

#### SECTION I - GENERAL AND ACADEMIC MATTERS

#### A. APPROVAL OF MINUTES OF MARCH 6, 2014, MEETING

On a motion by Mr. Boots, seconded by Ms. MacDonell, the minutes of the March 6, 2014, meeting of the Board of Trustees <u>were approved</u>.

#### B. ESTABLISHMENT OF NEXT MEETING DATE, TIME, LOCATION

Mr. Ziemer called on Vice President Brinker, who reported the next meeting of the Board of Trustees is scheduled for Thursday, July 10, 2014, in New Harmony, Indiana.

#### C. PRESIDENT'S REPORT

President Bennett reported on the highly successful launch of the new University and Athletic logos. Each Trustee received an umbrella bearing the new University logo.

Dr. Bennett called on Vice President Brinker to review the Commencement activities planned for the weekend. Ms. Brinker noted that 73 percent, or 1,088 of the 1,487 students eligible to graduate, will participate in Spring Commencement. She outlined the schedule of the five ceremonies:

Following each ceremony, the USI Alumni Association will host a reception in UC East.			

Dr. Bennett reported that during spring honors ceremonies in each academic college, USI celebrated the accomplishments of many fine students and faculty members. Since 1990, past and current members of the Board of Trustees have generously contributed to build a permanent endowment in the USI Foundation for the

Trustees Distinguished Merit Award. The awardee is selected by the Faculty Senate Student Affairs Committee and the award is the most prestigious presented during Honors Week. It recognizes outstanding achievement in the student's major and in the core curriculum and includes a \$1,250 stipend. President Bennett announced the 2014 recipient of the award is Samuel D. Barnett, a biophysics and Spanish studies double major who will graduate in 2014. She thanked the Trustees for their generous support of the Trustees Distinguished Merit Award.

Two other important awards to be celebrated during Commencement ceremonies are the Distinguished Professor Award and the President's Medal. President Bennett reported that Dr. Kent Scheller, associate professor of physics, was selected by his colleagues to be named the Distinguished Professor. Dr. Scheller joined the USI faculty in 1999. Jordan K. Morrison '14 will receive the President's Medal, the highest award given to a USI graduate, when he graduates *magna cum laude* with a Bachelor of Science in Nursing.

President Bennett called on Provost Rochon, who introduced Activities Programming Board (APB) President Aaron McCullough '15 and Student Government Association (SGA) President Zack Mathis '15 for a report of their organizations' activities. Mr. McCullough reported on several of the over 90 programs planned each year to provide students with entertainment and educational activities. He noted that new programs developed in 2013-2014 were primarily focused on achieving two of the University's Strategic Plan goals: become a 24/7 campus; and increase the diversity of the students, faculty, and staff. In addition to these new programs, APB hosted a variety of events during Welcome Week. Other popular events last year were the Halloween Dance, Homecoming Week entertainment, and a mini carnival. Mr. McCullough concluded his report by noting that ten APB members attended the NACA Mid-America Conference in Peoria, Illinois, November 7-10, 2013. Participation in the conference allowed members to attend leadership and programming classes, network with students from other universities, and collaborate with other universities to bring new and bigger acts to campus via "block scheduling."

Mr. Mathis began the annual report of SGA by noting SGA's varying roles on campus; the organization serves as a liaison between students and the faculty/administration; builds strong leaders; serves as a forum for student groups to voice their concerns; assists students with funding for travel; improves school spirit through SGA's birthday cupcake giveaway, Midnight Madness, and the annual t-shirt swap. Mr. Mathis identified the highlights of SGA's activities for the year. SGA hosted Attorney General Greg Zoeller and State Senator Jim Merritt on campus to inform students of changes in the Indiana Lifeline Law. SGA received a record number of requests for travel grants this year and funded those requests at a rate of 123 percent. SGA held another successful Alcohol Awareness Week, and promoted extended library hours as part of the 24/7 initiative. SGA members participated in the Ball State Student Government Coalition Conference and the annual USI Day at the State House.

President Bennett expressed her appreciation to Mr. Mathis and Mr. McCullough for their leadership in 2013-2014. She thanked Mr. Mathis for representing USI students in Board of Trustees meetings and events, and congratulated him on winning reelection for 2014-2015.

President Bennett called on Dr. Mary Hallock Morris for a report from Faculty Senate and thanked her for her service and leadership as chair of Faculty Senate in 2013-2014. Dr. Hallock-Morris reported that at the March 21 meeting, the Faculty Senate developed a proposal for the 2014-2015 year's budget hearings. The proposal included a request for a salary increase, an increase in per diem and mileage rates, an increase in funding levels for travel to conferences, an increase in full-time faculty lines, and an endorsement of the Rice Library's request for an increase in its base materials budget. In April, the Senate voted to endorse the formation of a committee to explore the implementation of college-level promotions/personnel committees and the revision of the promotions process. It also was announced that Joanne Artz from the Rice Library was elected as the new at-large Faculty senator and Sheri Keenan from the College of Liberal Arts was elected as the new at-large member of the USI Assessment Committee. The Pott College of Science, Engineering, and Education and the Romain College of Business are working to complete their elections by the end of the academic year. Dr. Hallock Morris advised that the new Faculty Senate leadership will be decided during the August retreat. In closing, Dr. Hallock Morris thanked her colleagues for their hard work and dedication and gave a special thank you to Faculty Senate Vice Chair Jason Fertig and Secretary Kristalyn Shefveland.

President Bennett called on Student Government Association (SGA) President Zach Mathis for a report. Mr. Mathis noted that the annual report from AGB/SGA just presented would take the place of the regular report

from SGA. He thanked President Bennett and the Board members for their support and stated he looked forward to working with them in 2014-2015.

Dr. Bennett referred the Trustees to a data dashboard in their handout packets, an annual snapshot of the previous year's (2013) graduating class. She highlighted data from the report, noting an 11 percent increase in the number of bachelor's degrees granted (compared to the class of 2012). She also noted almost one-third of the class came to USI as transfer students and thus would not count in the traditional graduation rate measure. Earning college credit or taking Advanced Placement courses while in high school offers an advantage to completion of a degree in four years. The dashboard shows that 59 percent of the class of 2013 with early college credits received bachelor's degrees in four years. Dr. Bennett discussed data about universities/colleges by origin for transfer students, the most frequent being Vincennes University, and Ivy Tech Community College Southwest. Transfer students from four-year institutions were most likely to come from Indiana University Bloomington, University of Evansville, and Indiana State University. Dr. Bennett discussed degree completion among transfer students and noted that since few students transfer with two full years of credits, most will take longer than two years to complete their degrees. Dr. Bennett concluded her report by referring the Trustees to additional data in the dashboard.

#### D. APPOINTMENT OF THE NOMINATING COMMITTEE

Mr. Ziemer appointed Mr. Romain, Mr. Boots, and Ms. MacDonell to the Nominating Committee, with Mr. Romain as chair. The Nominating Committee will prepare a slate of officers to be presented to the Board of Trustees at its annual meeting on July 10, 2014.

### F. REVIEW OF ACADEMIC PROGRAM DEVELOPMENT PLAN

Mr. Ziemer called on Provost Rochon, who referred the Trustees to the Academic Program Development Plan in Exhibit I-A. Dr. Rochon reported the plan is developed and reviewed regularly by the Academic Planning Council.

#### **SECTION II – FINANCIAL MATTERS**

#### A. REPORT ON CURRENT CONSTRUCTION PROJECTS

Mr. Ziemer called on Vice President Rozewski who introduced Director of Facility Operations and Planning Steve Helfrich for a report on the status of current construction projects. Exhibit II-A is a summary of the cost and funding sources for each project.

Mr. Helfrich began by reporting on a recently completed project, the repair and repainting of the exterior stairs and handrails on the Atheneum Building in New Harmony.

Projects under construction include the Teaching Theatre and the Teaching Theatre Support Building. Installation continues on the lobby curtain wall and glazing system. The installation of the brick on the exterior walls on the south side of the theatre is now complete. The interior of the theatre is approximately 85 percent complete and the architectural metal feature wall has been installed. A LED lighting system is being installed behind the aluminum wall fins. This lighting system will be programmable and will result in a unique and artistic feature in the theatre. Delivery of the sandstone from the quarry and mill is six months behind schedule. The latest schedule from the stone supplier provides for delivery of all of the stone by the third week of June, which will allow the building to be complete in late summer or fall 2014.

Construction of the Theatre Support Building is progressing with the improved weather. The foundation walls and footings are being installed which will be followed by the erection of a prefabricated steel building. The building is scheduled to be complete fall 2014.

Mr. Helfrich reported that bids were received for three renovation projects and the construction for each of them will begin mid-May. The projects include renovation of the lower level of the Science Center building, the Orr Center Classroom Renovation Project, Phase 1; and the renovation of the Hammond and Chase student apartment buildings in the McDonald East Complex.

Mr. Helfrich referred the Trustees to a list of Projects in Design in Exhibit II-A.

# B. REPORT OF CONSTRUCTION CHANGE ORDERS ISSUED BY THE VICE PRESIDENT FOR FINANCE AND ADMINISTRATION

Mr. Ziemer called on Vice President Rozewski to review the approved change orders for the Teaching Theatre Project. Mr. Rozewski referred the Trustees to a list of change orders in Exhibit II-B. He noted none of the changes required approval of the Board.
