June 21, 2002

The Finance Committee of the University of Southern Indiana Board of Trustees met on Friday, June 21, 2002, in Room WA100 of the Wright Administration Building. Present were Trustees J. David Huber and Tina Kern-Raibley. Attending via conference call were Trustee G. Patrick Hoehn and Associate Vice President for Business Administration Cindy Brinker. Also attending were Vice President for Business Affairs and Treasurer Robert Ruble; Vice President for Advancement Sherrianne Standley; Budget Director Mary Hupfer; and Director of the Business Office and Assistant Treasurer Michael Whipple.

Chair David Huber called the meeting to order at 8:20 a.m.

1. DISCUSSION OF CURRENT OPERATING BUDGET FOR FISCAL YEAR 2002-2003

Vice President Ruble reviewed the \$59.3 million operating budget for 2002-2003. He reported on issues related to the operating budget for 2002-2003, including a decrease in state funding, an increase in student fees, a technology fee effective in the Spring semester 2003, and anticipated increases in property and liability insurance, health insurance, and water/sewer rates. Committee members requested that at the July 1 Board meeting, staff give more detail on an engineering reserve fund and on anticipated increases in major expenditure areas. Additional detail on property and liability insurance rates will be provided as information on renewal rates becomes available.

2. APPROVAL OF BUDGET ADJUSTMENTS, APPROPRIATIONS, AND TRANSFERS

On a motion by Mrs. Kern-Raibley, seconded by Mr. Hoehn, the budget adjustments, appropriations, and transfers in Attachment A <u>were approved</u>.
