THE CLASS OF 2011

PROFILE FROM THE OFFICE OF THE REGISTRAR

The Office of the Registrar reports the following demographic information regarding the Class of 2011. It is included to provide a useful background for other data contained in this report.

- Between December 2010 and August 2011, 1,685 degrees and certificates were awarded to 1,635 individuals.
- Baccalaureate degrees were awarded to 1309 graduates. A total of 1316 baccalaureate degrees were awarded as follows: 929 Bachelor of Science; 169 Bachelor of Arts; 52 Bachelor of Social Work; 127 Bachelor of Science in Nursing; 10 Bachelor of General Studies; and 29 Bachelor of Science in Engineering.
- Among the graduates, 92.6 percent identified themselves as white, non-Hispanic; 6.7 percent of the graduates classified themselves as minorities; and .9.6 percent did not specify.
- Among the graduates, 68 percent were female, a 1 percent increase from 2010.
- 49.5 percent of the graduates were from Gibson, Posey, Vanderburgh, or Warrick counties, while 14.3 percent of degree recipients were from other area counties. Graduates from all other counties in Indiana represented 20.5 percent of the graduating class; 14.3 percent of the degree recipients were from other states; and 1.3 percent were from other countries .1 unknown.
- Baccalaureate degrees were awarded by the College of Liberal Arts (28.8 percent); College of Business (21.2 percent); Bower-Suhrheinrich College of Education and Human Services (15.3 percent); College of Nursing and Health Professions (24.4 percent); Pott College of Science and Engineering (9.6 percent); and Extended Services (.6 percent).

EXECUTIVE SUMMARY / FOLLOW-UP SURVEY

This report is a six-month follow-up of the 2010-2011 graduating class; responses were received from 47 percent of the graduates.

EMPLOYMENT RATES

- 75.2 percent of respondents are employed; 81.1 percent of employed respondents are full-time, 18.8 percent of employed respondents are part-time. 15.5 percent of employed respondents are still seeking; 27.7 percent those still seeking are full-time, 26.6 percent of those still seeking are part-time.
- There were only 35 unemployed bachelor graduates not working and not enrolled in additional coursework or attending graduate school that were actively seeking employment.
- 8.42 percent of unemployed respondents are either enrolled in additional academic coursework or have chosen not to seek employment at this time. 26.3 percent of unemployed respondents are actively seeking employment. 24.7 percent of respondents are unemployed.

- Of the graduates who are employed, 62 percent have secured new positions with a new employer, 13 percent have secured new positions with the same employer and 24 percent are employed in the same position they held prior to graduation.
- Among bachelor degree recipients who are employed 87 percent are working "in their field or in a field in which they expressed satisfaction." (Education majors employed as substitute teachers are coded as working "in their field".)

CONTINUED EDUCATION

- Among bachelor degree recipients who completed the questionnaire, 21 percent were attending graduate school within a year of graduation.
- Among associate degree recipients, 27 percent are currently completing requirements for a baccalaureate degree.
- Among bachelor degree recipients, 2.2 percent are enrolled in additional undergraduate coursework.

GEOGRAPHIC LOCATION

- Among all employed graduates, 70 percent accepted employment within the tri-state (a 60-mile radius of the University), an increase of .6 percent from 2010. Sixty-two of these individuals reside in Kentucky or Illinois.
 - 15.9 percent of the employed bachelor degree recipients left the tri-state area in 2011.
 - 11.4 percent of the employed master degree recipients left the tri-state area in 2010.
 - 17.6 percent of the employed associate degree recipients left the tri-state in 2010.
- Among all 2011 graduates, 4.62 percent left the tri-state to accept employment elsewhere in Indiana, bringing the total number of 2011 graduates who work and utilize services in Indiana to 73 percent.

SALARY STATISTICS

- The average starting salary for baccalaureate degree graduates securing NEW, FULL-TIME POSITIONS was \$34,624, a .7 percent increase over the average starting salary of \$34,364 in 2010.
- The average starting salary for associate degree graduates securing NEW, FULL-TIME POSITIONS was \$34,625 a decrease of 24.6 percent from the average starting salary of \$45,921 in 2010.
