    - 1. All full-time support staff who earn less than \$10.50 per hour have their pay adjusted to a living wage of \$10.50. All other support staff employees should receive a pay increase as the 2015 funding levels allow with a target increase of no less than 3%. To resolve wage disparity and compression, we propose a sliding scale increase for employees earning above \$10.50. Employees on the lower end of the salary should receive a higher raise increment and top paid support staff should receive a lower percentage.
    - 2. For those employees earning less than \$25,000 per year, offer child care at a reduced cost, \$100 per week.
    - 3. Increase the fee waiver from 15 credit hours to 21 credit hours per semester.
    - 4. Allow employees to use their one paid volunteer day to be used for the charity of their choice not just United Way's Day of Giving.
