## C. Budget Adjustment

  - ✓ Documentation must include a written statement detailing the number of miles per day (in excess of 60 miles round trip) and the number of days per week you drive to Evansville.
- ☐ Off campus-housing (Students who reported living on-campus or with parents on FAFSA, but are now living off-campus in an apartment or house)
  - ✓ Documentation must show your name and monthly charges.
  - ✓ Examples of documentation include your lease or rental agreement.
- ☐ Computer Expense (One-time purchase of a computer, not to exceed \$1800)
  - ✓ Attach proof of purchase.

  - ✓ We **cannot** consider expenses incurred/paid by roommates, spouses, and children or other family members, car payments, credit card payments and expenses incurred outside of the current enrollment period.
