1. The specifications mention non-touch display units—would the university be open to considering **Interactive Flat Panels (IFPs)** as an alternative, provided they meet or exceed the required specifications? The Touch functionality for the touch panels can be disabled if required by your use case.

IFPs can be an alternate bid.

2. Would **partial bidding** be permitted, or is it required that proposals cover all listed items?

No partial bidding.

3. In terms of logistics, does USI require **installation services**, or is the scope limited to **shipping and after-sales support**? Additionally, could you provide guidance on the **expected lead times** for delivery post bid award?

Installation is required.
