Your loyal friendship continues to advance the University of Southern Indiana to new levels of excellence.

The Class of 2023 for the Nursing, Dental Hygiene and Respiratory Therapy programs achieved a 100% pass rate on licensure exams. These 115 students joined our alumni body now 50,533 strong.

At only 58 years of age, USI remains a young institution of higher education. Our students represent 87 Indiana counties, 47 states, and 40 countries. This past August the freshman class came in with an average GPA of 3.41 on a 4.0 scale—evidence of our ability to attract students with strong academic aspirations and standards. This year we achieved a record number of 1,854 graduate students.

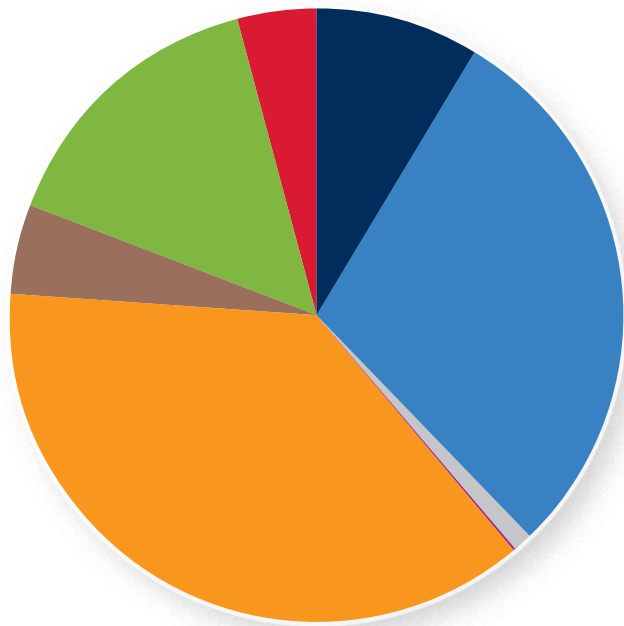

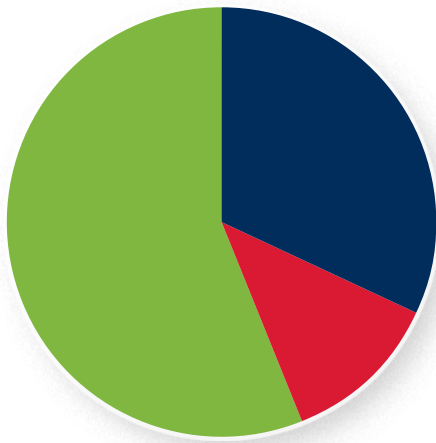


# Consolidated Statements of Financial Position



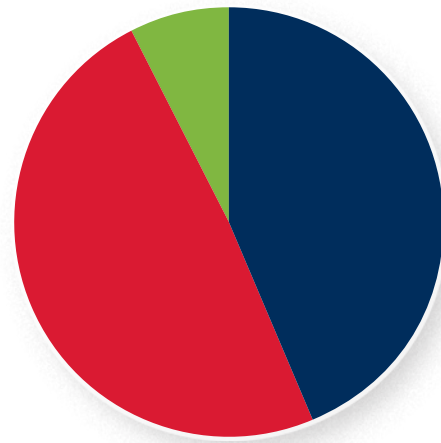
